ELIGIBILITY

1. The contest is open to people aged eighteen (18) or above residing in Hong Kong. Participants must hold a valid Hong Kong ID and a valid Passport (and a valid visa if applicable) with at least 6 months of validity prior to entry of France on 9 July 2017.
